Extra curriculum fees, e.g. Band fees, Music camp, Duke of Edinburgh scheme and sports activities are not included in the College Education Fee and will be payable during the year via your school's alternative payment platform.

Sibling discounts

Mater Maria Catholic College remains firm on our commitment that no family in a CSBB school will be denied a Catholic education because of financial difficulties. Where parents or carers are billed an education fee for more than one child enrolled in a CSBB systemic school, the account will be eligible for a discount to the Education Fee (Sibling Discount). The discount will be automatically applied to the 2024 invoice, based on the number of Education Fee charges billed to an account.

In 2021 CSBB made the decision to increase benefits for those in CSBB systemic schools by streamlining our fee structure, increasing the discount rate for siblings, and applying it to the entire Education Fee. Consequently, over time, it has also required us to reassess how these benefits are directed. Therefore, we have made the decision that sibling discounts will only apply to the Education Fees for children enrolled within the CSBB Systemic system and will no longer be extended to families where older siblings attend schools outside the CSBB School system, including independent Catholic schools. Additionally, there was no consistent reciprocation of these discounts.

Billing

School fees are billed annually at the beginning of Term 1 by CSBB and are due in 10 monthly instalments. The first instalment is due 21st of February and the last payment being 21 November. School fees may be paid more frequently (annually, fortnightly, or weekly), however the monthly instalment amount is to be paid by the 21st of the month.

Our preferred method of payment for fees is BPAY. Fees can also be paid EFTPOS and Credit Card.
